SUBJECT: **Medical Marijuana Licensing Scoring Results**

DATE: November 30, 2018

Earlier this year, Buena Vista Charter Township adopted an ordinance to regulate medical marijuana facilities under the Medical Marijuana Facilities Licensing Act, MCL 333.27101. The Township has limited the number of licensed medical marijuana facilities as follows:

Facility	Number of Licenses
Grower	3
Processor	3
Secure Transport	3
Provisioning Center	3
Safety Compliance	3

The Township developed scoring criteria for the review of medical marijuana facilities in Buena Vista based on the best practices of other Michigan communities. Under the scoring system, one point is awarded for each criterion met. The maximum number of points that can be awarded is 81. The Township opened the application submittal window in September 2018 with October 1, 2018 as the final day that the Township would accept applications.

The following are our preliminary findings.

APPLICATIONS

The Township received seven applications for eleven licenses. Each license application has a \$5,000 nonrefundable fee.
